

Status

- PEPPOL BIS Billing 3.0 published February 28th.
 - Core Invoice Usage Specification (CIUS) according to EN **16931 Electronic Invoicing**
 - Norwegian rules included in PEPPOL BIS Billing 3.0
 - Introduces 1-1-1 principle
- Review of EHF Billing 3.0 between March 1st and April 30th.
 - No comments received
- Contains two syntaxes.
 - UBL is the preferred syntax by OpenPEPPOL



Timeline

- March 31st 2017: Official notification
- March 1st 2018: Review of standard
- August 31st 2018: Release of standard




- January 1st 2019: Mandatory use of standard
- January 1st 2020: Removal of previous standard

Current status

- Mandatory usage delayed until April 1st, 2019 for public sector
- Removal of existing registrations in ELMA on January 1st, 2020 delayed until further notice
- Disabled old spesifications for registration in ELMA
- Large adoption of receive capability in ELMA

End of life: Old EHF specifications in post-award



PEPPOL BIS Upgrade 3.0

- Project to upgrade and harmonize remining specifications in post-award based upon the Peppol BIS Billing 3.0.
- The Peppol Community agreed upon a migration plan.

- Peppol BIS Order only 3.1
- Peppol BIS Ordering 3.1
- Peppol BIS Catalogue only 3.0
- Peppol BIS Catalogue without response 3.0
- Peppol BIS Despatch Advice 3.0
- Peppol BIS Punch Out 3.0
- Peppol BIS Order Agreement 3.0
- Peppol BIS Message Level Response 3.0
- Peppol BIS Invoice Response 3.0


Notification (2)
